All her life Marta struggled to find a place that felt like home. At a young age, she and her sister were removed from the care of her parents, who struggled with addiction. The state placed the girls in a group home for children, where she experienced abuse by the staff. Throughout her life, Marta was betrayed by the individuals who were supposed to protect her, surviving the best way she knew how, but never arriving at true safety. She placed her trust in individuals who told her they loved her, but who only turned around and dominated and controled her with violence. Marta learned that the best way to survive was by constantly staying on guard, trusting no one, and expecting the worst in people.

Marta found Hope Alliance after being sexually assaulted in a romantic relationship that had turned abusive. She reported the assault to the police, and found Hope Alliance, but she continued to experience



extensive victim-blaming by her abuser, her family, but also by the authorities who were supposed to protect her. Marta feared retaliation by her abuser, so, she isolated herself in her home and grew distant from her support system. Even though she had been failed by so many, she took the very courageous step in asking for help from

Hope Alliance's counselors and legal advocates.

IMPACT STORY CONTINUED

The support she found at Hope Alliance allowed her to access funds through Crimes Victim's Compensation, enabling her and her beloved pets to move into a new apartment in a different city where her abuser could not easily find her. In the counseling program, Marta built a trusting relationship with her counselor and finally explored how her life of abuse resulted in mis-guided core beliefs about herself that prevented her from reaching her goals.



After a lifetime of being told that she would never amount to anything, and being blamed for the actions of others, she was able to change the story she told about her own life, no longer believing that the abuse made her broken or unworthy of love.

Marta found ways to cope with her disturbing memories, and channeled her pain into her art. She shared her paintings with her counselor via virtual therapy, and she was finally able to express herself and open up about what she had been through with someone who really cared and who understood the dynamics of domestic violence. Marta worked with her counselor to create a transition plan so that she could continue her healing work with a long-term trauma therapist.

The accessible services and support offered by Hope Alliance allowed Marta to begin to establish true safety in her life for the first time, changing the narrative imposed upon her by others and giving her human relationships from which to draw strength. Getting out of survival mode gave Marta the emotional security she needed to think about the future, rather than just surviving the day.

IMPACT DATA

Hope Alliance collects every piece of data we can. We believe in reporting on all our Direct Services in a straightforward, transparent way. At the same time, Hope Alliance is equally dedicated to spending a donor's contribution as effectively and efficiently as possible. Hope Alliance provided the following services So far this year to date as of end of September 2024:

Total number of clients served = 3,695



Total number of service sessions provided = 21,331 Total Sheltered Nights of Safety provided = 6,698 Total number of sheltered clients served = 381 Total number of Hotline calls answered = 3,235 Total web-based Crisis Chats answered = 327 Total sexual assault accompaniments = 141

We keep track of more data than shown above. By doing so, we attempt to let our donors know what we accomplish with their financial support. However, the point is that donors ought to know that Hope Alliance is dedicated to helping clients break the cycles of abuse in which they live.

" I did not know that as a 58-year-old woman the things that happened to me caused me to react in survival mode. I am truly happy that the help here opened my eyes and made me aware of my trauma response. I hope this will help guide me in the future to a more fulfilling happy life."

MORE IMPACT DATA

Continuously evaluating and refining our programs based on insights gained from our clients' exit surveys demonstrates a commitment to evidence-based practice and ongoing improvement. It also underscores our organization's dedication to meeting the evolving needs of our clients and maximizing the impact of our services.

Clients exiting our care in August 2024 told us the following:

- · 83% FEEL SAFER,
- · 93% FEEL LESS ALONE,
- \cdot 87% feel more hopeful,
- \cdot 93% feel positive of goal process
- \cdot 80% learned more about family & sexual violence, and
- · 96% was the overall satisfaction rating.

When our clients tell us we helped them save their lives, the survey results above support their claim.













HOPE ALLIANCE PREVENTION EDUCATION

Over the last three months, we've been happy to continue our partnership with The NEST and are excited to continue the partnership into the next school year.




We have been in talks with both The Georgetown Public Library and Southwestern University about partnering together starting next school year. SOUTHWESTERN

Hope Alliance's Prevention Education Program utilizes four core components in our community work:

- **Know your community** through an active, ongoing process to identify community dynamics and readiness.
- **Cultivate relationships** intentionally cultivate inclusive and mutually respectful relationships • within the community.
- Involve Youth and allow them to guide programming promote opportunities for youth and • young adults to inform, plan, and lead community-level work.
- Foster a supportive environment encourage communication that values everyone's opinions and enhances their ability to affect change.
- Foster cross-collaboration understand the causes of violence and factors that can protect • people. Violence can include sexual violence, intimate partner violence, and bullying. These forms of violence often share similar root causes. Identify and foster partnerships that align with sexual violence risk and protective factors. Support mutual collaboration and collective action while honoring the group's capacity.
- **Be action-oriented** cultivate and support the progressions of community-based initiatives based • on readiness.
- **Promote community ownership and leadership** foster shared decision-making to strengthen • leadership and sustainability. Highlight, enhance, respect, and celebrate progress.

FROM THE CEO - Richard M. Brown, Ed.D.

In the last issue of "The Ally," I wrote about "Bequests" being the most common, efficient and effective ways to support future life-saving work of Hope Alliance. Several different types of bequests were defined. Since the last newsletter was published, we are both thrilled and honored to announce that two different donors told us about two different types of bequests they plan to make to Hope Alliance. They are two more very special Legacy of Hope Society Members.

One bequest will be a **Percentage Bequest** of a large portion of the donor's estate. The donor also specified that the bequest to be



received shall be used to establish a permanent Endowment Fund with her mother's name to memorialize her mother who was murdered by her stepfather in a domestic violence incident in 1995.

Endowment funds can be managed in many ways. In this case, in agreement with the donor, Hope Alliance will invest the entire amount of the bequest received from the donor's estate after her death. The principal, or corpus of the gift will stay invested forever and never be spent. The Endowed Fund will be invested according to Hope Alliance's investment guidelines which are focused on long-term growth. On the anniversary date of the establishment of the endowed fund, 85% of the account's investment earnings will be calculated and transferred from the investment account to Hope Alliance's general operating account, and spent on operational expenses. The remaining 15% of the investment earnings will remain in the investment account and be officially considered to be part of the corpus of the original gift. This cycle will be repeated yearly. Such a process will guarantee growth in the account, and it will also guarantee larger contributions to the general operating fund well into the future.

The second bequest will be a **General Bequest** of a specific dollar amount from the donor's estate after her passing. The donor is permitting the Hope Alliance Board of Directors and Management Staff to decide the best use of the bequeathed funds when received.

We believe that one should always consider taking care of their family first when creating an estate plan. If there is any portion of the estate available for charitable purposes after taking care of the family, then please consider distributing some of the estate to Hope Alliance thereby becoming a member of the Hope Alliance Legacy of Hope Society. Please contact us at your convenience about your plans to do so. We'll discuss various options with you, your financial advisors and/or your estate planning attorney to help you reach your estate planning goals.

WE'RE MAKING PROGRESS!

Hope Center Update

If you've heard anything about Hope Alliance lately, then you're probably aware that we're working to expand our services and relocate to Leander, TX. We conducted a ceremonial groundbreaking event on June 28, 2024. On August 7, 2024, we received our Site Development Plan Permit from Leander's Planning and Zoning Commission. A few days later, we broke ground FOR REAL, and we started the 12 to 15 month building process. Click on the Hope Center tab and you'll see pictures, a progress chart, and soon, you'll see still photos and time-lapsed video from the EarthCam we installed at the building site at 1161 West San Gabriel Parkway, Leander, TX 78941.

As of this writing, the "Pad Site" (picture to the right) is complete. The "Pad Site" is the location on which the concrete slab for the Hope Center will be poured. Installation of utilities, including water, sewage, electricity, gas and internet are in various stages of completion. The city required a concrete wall on our north property line to buffer the residential subdivision to the north. The concrete wall is complete. The construction fence is installed, and water detention pond construction is ongoing.

In the near future, underbrush and "trash trees" will be cleared from underneath the oak trees which will not be disturbed in the building process. We're calling this area of our project "The Forest." Soon we'll have a certified arborist on site to lift oak tree canopies and to trim deadwood. In a future project, The Forest will be a location for clients and staff to have a peaceful place for relaxation and contemplation. The forest will have pathways, park benches, perhaps bird feeders, etc. If you know of a corporate entity, civic group, or faith community that would make our





"Forest" a beautiful, peaceful, relaxing place to be, then please let us know!

The Hope Center is designed to include community partners that will be able to provide clients with all the services available to people who experience trauma from their abuse. Hope Alliance still has a bit of work to finish in terms of finalizing official partnerships, but we can report the following entities will help provide services from the new Hope Center:

- 1. Asian Family Support Services of Austin
- 2. Children's Advocacy Center
- 3. County Attorney's Office
- 4. District Attorney's Office
- 5. Goodwill Industries
- 6. Williamson County Sheriff's Department
- 7. Unbound Now (Anti-Human Trafficking Agency)

We intend to finalize partnerships with one more entity, and we'll report accordingly as it occurs. There will be an update in each newsletter published until we occupy the new Hope Center.
